- 8-07-02** APOLOGIES for absence were received and accepted from Cllr Olsson.
- 8-07-03** There were no **DISPENSATION** requests and no **DECLARATION OF INTEREST** on items on the agenda.
- 8-07-04** It was **RESOLVED** to accept **MINUTES** of the meeting held on 13 May 2021.
- 8-07-05** It was **RESOLVED** to object to the **PLANNING APPLICATIONS** for 11 Bakers Lane, Shutlanger.
- 8-07-06** It was **RESOLVED** to accept the **FINANCE REPORT** presented by the Clerk.

8-07-09 It was **RESOLVED** to adopt the **PARISH PLAN** presented by the Clerk.

8-07-10 **ITEMS MEMBERS OF THE PUBLIC** wish to raise were discussed.

It was agreed that the council should get involved in nomination of residents for their efforts. It was suggested that this be progressed in 6 months and nominations sought from the village.

The development on Twitch Hill will be investigated further by the Clerk.

It was agreed that the Clerk would investigate the costs and the necessary planning approval for a new Dog Waste Bin to be in the alley between Twitch Hill and Main Road.

The Clerk will notify Highways that there are blocked drains in the village.

An update was received from the Village Hall committee member, and it was agreed that the Village Hall would supply status report showing how the funds from the council have been spent.

The Clerk advised that there are no plans for BT to offer Fibre to the Home any time soon but advised that Gigaclear have plans to start work installing their infrastructure in the village in the next 3-4 months. The Clerk advised that there will disruption during the works.

Village befriending was discussed and will be discussed within the Village Hall committee.

Ability bus service will be once again promoted on the Website and the Facebook Site.

It is being considered to have a "Closed" Facebook site for the village, Cllr Evans will discuss with Cllr Olsson.

It was agreed that the Clerk would get quotes for refurbishing the railings on the Twitch Hill / Main Road Alley.
